Committee Chair Bob Smith provided communication committee update. He touched upon the fourth quarter community directory.

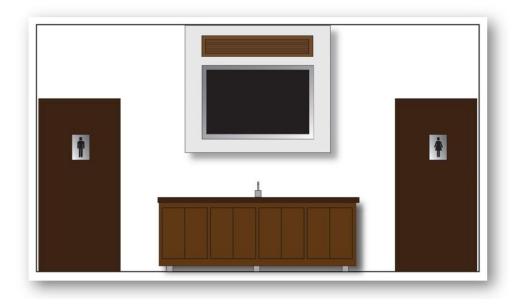
SECURITY
