## KAYAK RULES

1. Storage of kayaks under the pier is offered as a courtesy and is limited to one kayak per homeowner and is subject to availability.
2. Kayaks must be registered on annual basis and display the HOA registration sticker. Registration Forms are available at the Gatehouse or on the HOA website and must be updated annually each January.
3. Kayaks may be stored under the Pier throughout the year except when there is a hurricane alert. At such time all kayaks must be removed immediately. If a kayak is not removed in a timely manner it will be removed at a cost to the owner of \$100. If you will be absent from The Estuary during hurricane season for an extended period of time you must remove the kayak prior to your departure.
4. Only residents of the Estuary may store kayaks at the pier.
5. Kayaks must be stored only in the designated area under the pier above the mean high tide line and in an inverted position as to not hold rainwater. Note: Self-bailing kayaks are permitted to be stored in an upright position.
6. Any Kayak secured or affixed to the pier structure with a lock, must use a combination lock. The combination must be listed on the registration form. No key locks are permitted.
7. Owners will forfeit their right to store kayaks under the Pier for twelve months for any violation of the above rules.
8. Kayaks whose owners fail to abide by these rules are subject to removal and disposal by the Association at a cost to the owner of \$100.

I understand and agree that by storing the above described kayak in the designated area that I hold harmless and agree to indemnify the Delray Estuary Homeowners Association, its officers, directors, employees, managers, and such other agents designated by them (all hereinafter referred to as Association and Agents), from any and all liability or responsibility for damage to or caused by such boats including injuries to myself and/or to any other persons, or damage to my kayak other kayaks or incidental to the use of or presence of these kayak(s) on or proximate to association property. I specifically grant permission to Association and Agents to physically move and relocate such kayaks within association property as may be deemed necessary or appropriate. I also grant permission to the Association and their agents to remove and discard any watercraft/kayak not properly registered with the Association and clearly marked with the supplied identification tag affixed to the hull.
