MANAGEMENT REPORT

- Tree trimming was performed, but not all trees appear to have been done. Steve from Only Trees
 returned to the community to do palms and a couple of hardwoods that were reported as having
 been missed. Owners who believe their trees need additional attention should contact the manager

- Area in circle at main gate has been reviewed for removal/replacement of plants and addition of LED lighting. It was suggested that a landscape architect be hired to review and provide input on the entryway landscape and lighting.
- Note that the lawn weeds have been in decline since the weed control experimental program began. Safe Planet moved into section 2 to begin the process there.
- Irrigation Work Orders are being addressed as problems are reported and the 'monthly wet-checks'
 to inspect all equipment (each sprinkler head is looked at while it is running to adjust to the correct
 spray) are being done on schedule.
- Lake Masters treated the vegetation in both lakes, the outer grasses are dying off and the lake banks should be clearing up as the process continues.

OLD BUSINESS

• Joe Hurtuk reported that the proposal for additional security cameras should be ready for the November meeting.

NEW BUSINESS

- Legal updates were presented to the Board for informational purposes.
- Upgraded paint specs were provided for review.
- Proposal for installation of LED lighting in front entrance was provided. BOD asked for additional bids due to cost of equipment.
- Acceptance of Annual Legal Retainer for 2017 approval was motioned by J.L., seconded by Julie.
