### **ALC Report**

- Gutter color on 1515 need to match adjacent surface (white)
- Need to finish North wall per Meredith will be complete next week
- ALC postponed a decision on replacing the coconut palms by the pier. The Fishers have proposed that they pay to have their coconut tree transplanted to the pier. We will get an estimate on that and see if they are still interested.
- Narrowed contractors for front entrance to 2 finalists. Will seek input from Old Palm Grove and bring final 2 proposals to BOD within 2 weeks.
- The proposal/bid for Calophyllum outside the south wall is \$3,715. Since these do not need to be big trees at this point we will ask Will for an estimate on smaller ones.
- Areca replacement phase 3 is playground to Estuary Way
- Commented it was difficult to get interested bidders for small jobs like the fence repair on the North wall
